**INSTRUCTIONS OF ROLLS.**—Corrections on muster rolls, after muster and before they have been forwarded to The Adjutant General of the Army, will be made with the approval of the mustering officer. Retained rolls will not be changed until authority therefor has been obtained from The Adjutant General.

**10. DETACHMENTS.**—This roll will not be used to muster detachments.

**11. DISPOSITION MADE OF ROLLS.**—Within three days after each bimonthly muster, the mustering officer will forward to The Adjutant General of the Army a copy of the muster roll of each company, battery, troop, or detachment. A duplicate of the muster roll will be retained in the Adjutant General's Department. The roll for The Adjutant General's Office will be folded evenly in three folds, with the first and the outside. It will not be folded or crumpled to fit an envelope, but will be mailed in an envelope of the proper size or in a wrapper made especially for the purpose.
